TERMS AND CONDITIONS OF WINTER STORAGE AND SPRING LAUNCH RESERVATIONS

1. I hereby authorize the above repair work to be done with the necessary material and hereby grant you and/or your employee permission to operate the boat herein described on local waterways or elsewhere for the purpose of testing and/or inspection.
 2. Dealer not responsible for unavailability of parts or delays in parts shipments beyond dealer control or for the loss or damage to boat or articles left in boat in case of fire, theft or any other cause beyond our control.
 3. Vessel owner is required to provide dock lines for spring launch. If none are on board, you will be billed for new ones.
 4. Any wet storage boats not staying with us for the summer season will be required to leave by April 15th, 2011. No exceptions. Any boat here after April 15th 2011 will be subject to a \$5.00/ft per day storage charge.
 5. Due to insurance regulations: No work below the boot stripe is permitted, including bottom paint, thru hulls, zincs, etc.
 6. **NON-PAYMENT.** In the event of non-payment after receipt of this bill for repairs or materials, pursuant to this work order, I agree that an expressed mechanic's lien is hereby acknowledged on above boat to secure the amount of repairs thereto. In accordance with the provisions of the State of New Jersey Statue and hereby represent to Schrader Yacht Sales, Inc, that I am the owner of the vessel and have authorization to order or request repairs. In the event that the balance is thirty days past due, and it's necessary to turn my account over to an attorney for collection, then I agree to pay, in addition to all other costs, interest or penalties, reasonable attorney's fees, with a minimum of \$250.00 to be added to the balance due under this bill.
 7. **INTEREST.** I agree that all invoices thirty days past due pay a 2% per month service charge which will continue until this indebtedness is paid in full.
 8. **JURISDICTION.** In the event there are any disputes arising out of any repairs, maintenance or installation of any materials on my boat, I agree that the jurisdiction shall be vested in the Superior Court of New Jersey, Law Division at the Ocean County Court House, Toms River, NJ and hereby consent to in personum jurisdiction, by means of forwarding to me a Summons and Complaint by certified mail, return receipt requested to my address.
